**Objectives:** This recorded session introduces learners to the key aspects of contract formation and how they interrelate with each other.

**Trainer:** Jemma Cox

**Trainer biography:** Jemma is a Chartered Trading Standards Practitioner working for a Local Authority in South Wales and has worked in consumer protection law for over 17 years. She is a Lead Officer in civil law for the Chartered Trading Standards Institute (CTSI), a role which she has held for nearly 10 years. She represents the Trading Standards profession in consultation responses, media interviews and writing for Business Companion. Prior to joining the Trading Standards profession, Jemma was a Generalist Advisor at the Citizens Advice during her law school studies and a Senior Advisor at Consumer Direct Wales. Jemma is a Lead Officer for Training and Professional development for Trading Standards Wales and the Welsh Branch of CTSI and is an executive member of the Institute of Consumer Affairs. She has a PGCE and is an experienced University tutor who has taught law and business for nearly 15 years. Jemma is also part of the training, assessment, and moderation team on CTSI's qualification framework and hosts a podcast which promotes the work of Trading Standards called Ask the Regulator.

- Explain the difference between an invitation to treat and an offer;
- Identify the key elements of acceptance and how the method of acceptance impacts upon the formation of a contract;
- Describe intention to create legal relations and its relevance to contract formation;
- Define consideration and identify different types of consideration;
- Identify the key elements of contract formation and how the elements relate to each other.

**Who should attend?** The session will be suitable for Trading Standards and Consumer Protection staff who need an introduction or refresher on the law of contract and the basic principles of how contracts are formed. This course contains practical examples and questions to help develop the learner's knowledge.
