

# Annual Federal Tax Refresher (AFTR) Course Syllabus

#### **CPE Credit Requirements**

- AFTR Exam: Must pass with a minimum score of 70% within a three-hour time limit. Exam must be completed in one sitting.
- **Exam Attempts:** Up to **2 attempts** permitted before receiving a different test version.
- Additional CE Courses: Any additional courses require a 70% passing score on the knowledge assessment for CE credit.
- Completion Deadline: All course work and exams must be completed by December 31, 2025 to qualify for the AFSP Record of Completion.
- **Note:** Enrolled Agents (EAs) do **not** receive CE credit for the AFTR course.
