## STUDENT NON-DISCLOSURE AGREEMENT

This Agreement is made and entered into by and between Wild Pregnancy Free Birth Education Class ("WPFB Education Class") and ("Student") for the purpose of receiving certain confidential information of WPFB Education Class to enable the Student to undertake the course described at the end of this Agreement ("Course").

WPFB Education Class and Student hereby agree as follows:

- 1. "Confidential Information" means proprietary and confidential information of WPFB Education Class marked or identified as such in accordance with Section 2 below.
- 2. To be treated as Confidential Information, any information provided by WPFB Education Class to Student in tangible form shall be marked "Proprietary and Confidential" or similar markings. Information disclosed orally must be identified orally as confidential at the time of disclosure.
- 3. No information will be Confidential Information that: (i) is already known to Student, or (ii) is or becomes publicly known through no wrongful act of Student, or (iii) is received by Student from a third party without similar restrictions and without breach of this Agreement.
- 4. Except as provided herein, Student will not disclose any Confidential Information to any other person. Student will not use any Confidential Information other than in connection with the Course.
- 5. Student may disclose Confidential Information (i) to other students who have executed non-disclosure agreements with WPFB Education Class, (ii) in response to the lawful request or requirement of a governmental agency or by requirement of law, and (iii) to the faculty member supervising the Course, provided that faculty member has signed a non disclosure agreement with WPFB Education Class.
- 6. WPFB Education Class understands that to complete the requirements of the course in which Student is enrolled, Student may be encouraged to share a screenshot or photo of the Course to a social media audience that will not have signed non-disclosure agreements, and that such screenshot or photo will include information about the WPFB Education Class. WPFB Education Class will work with Students to prevent the inclusion of Confidential Information in the screenshot by limiting the screenshot and photo to still photo only with no audio or video and any written materials prepared by the Student. If the Student chooses to share this image on social media, the Student is required to tag the WPFB social media account.
- 7. All Confidential Information delivered by WPFB Education Class to Student will be and remain property of WPFB Education Class. All Confidential Information, and any copies thereof, will be promptly returned to WPFB Education Class or destroyed by Student upon WPFB Education Class's request.
  - 8. The obligations of Student under this Agreement shall terminate five years after conclusion of the Course.
- 9. This Agreement may not be modified except by written instrument signed on behalf of each party. Either party may assign this Agreement to a parent corporation, to a wholly owned subsidiary or a successor of substantially all of the business or assets of the party. This Agreement embodies the entire agreement and understanding of the parties and terminates and supersedes all prior independent agreements and under takings between the parties. The provisions of this Agreement shall be construed in accordance with the laws of the state of North Carolina. All notices, requests or consents given in connection with this Agreement shall be given in writing and sent by first class mail, postage prepaid, telegram, teletype, telex, cable or email to the addresses listed at the end of this Agreement, unless either party notifies the other party of a different address.
