

Guide to Substance Use Disorder Treatment and Recovery



Course Overview

In this course you will gain an understanding of substance use disorder (SUD) treatment and recovery practices and principles. The course will review the signs and symptoms of SUD and how the process of screening and assessment helps determine the next steps and the required level of care.

In addition, participants will learn how the process of change can contribute to interrupting the addiction cycle and achieving recovery. The course will define effective, clinically proven treatment principles and the importance of providing an individualized, multi-faceted approach to treatment and continuum of care.

- Explain: The importance of an individualized, multi-faceted approach to assessment, treatment, and recovery. The four dimensions of recovery & their alignment to the ten guiding principles of recovery.
- Identify: Evidence-based treatment services and identify available resources.
